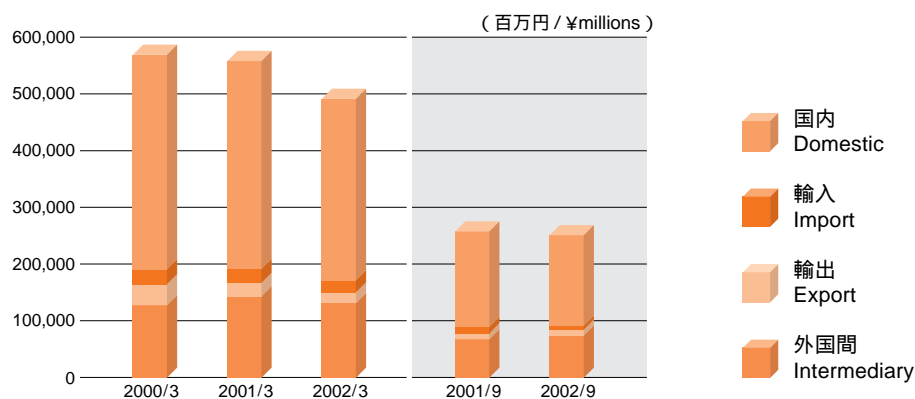

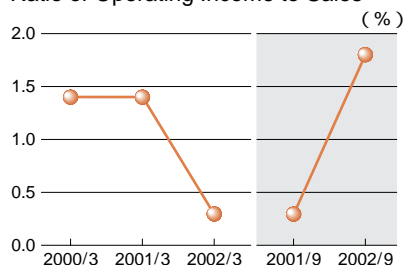

Ratio of Gross Profit to Sales



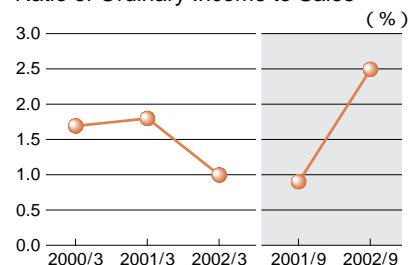

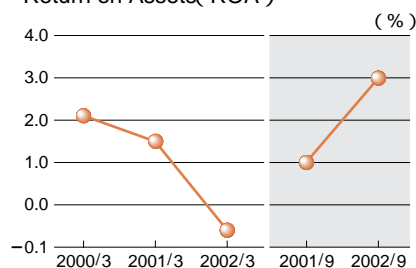

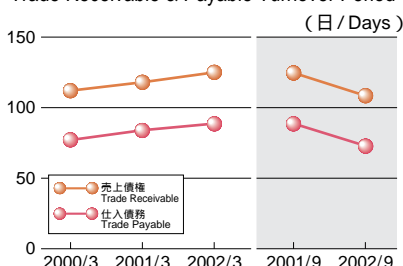

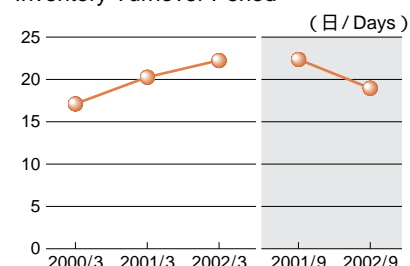

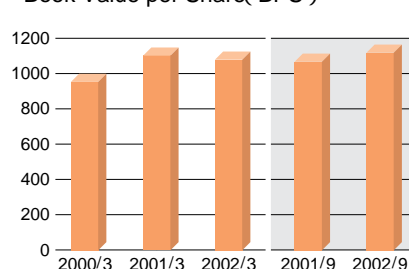

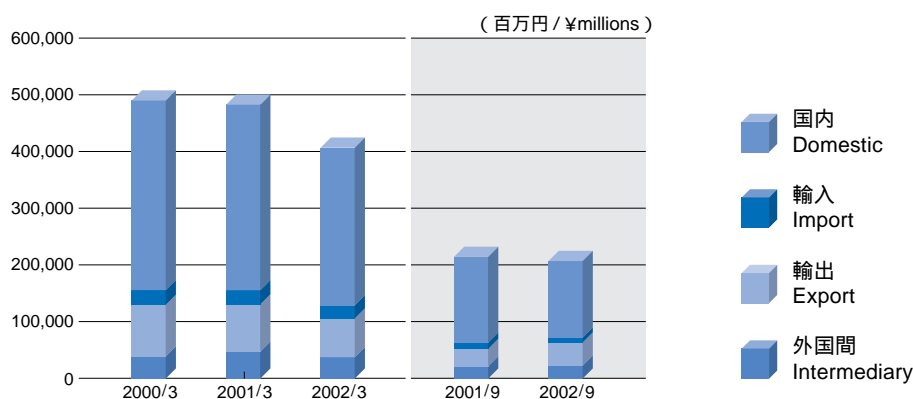

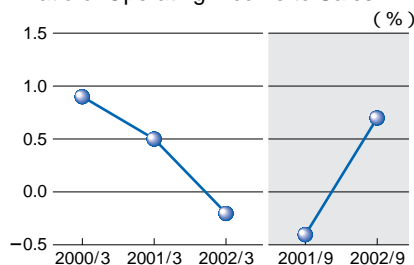

Ratio of Gross Profit to Sales



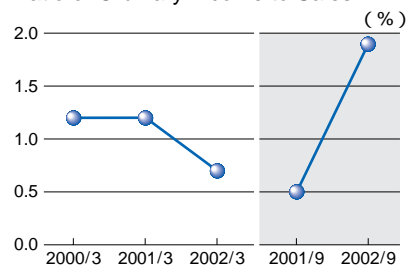

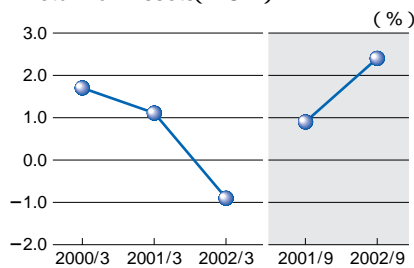

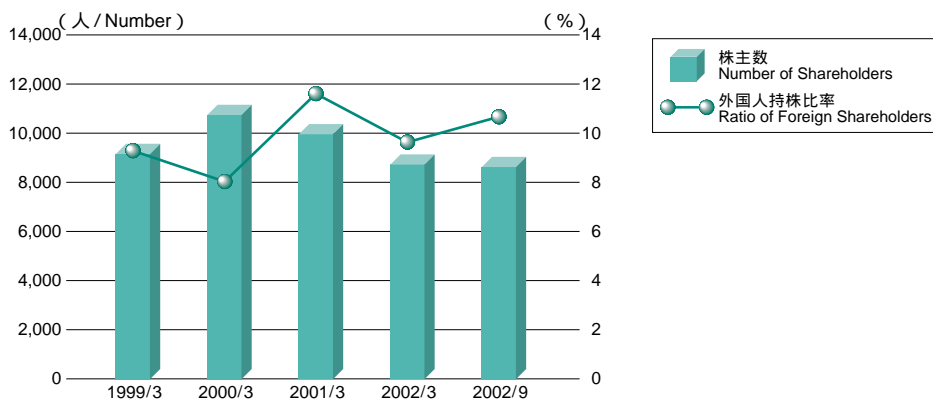
