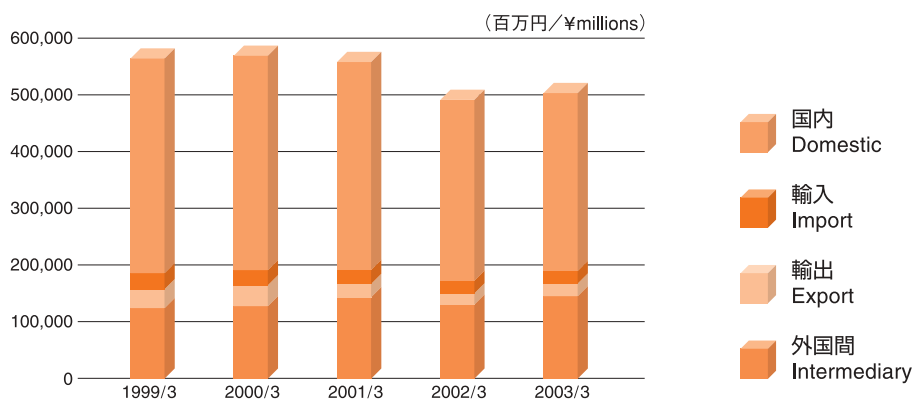

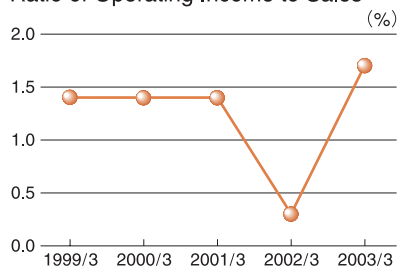

Ratio of Gross Profit to Sales



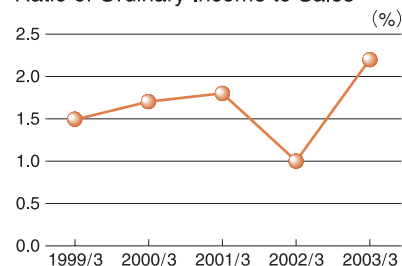

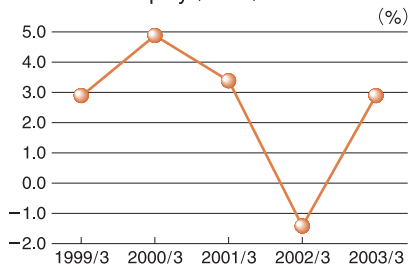

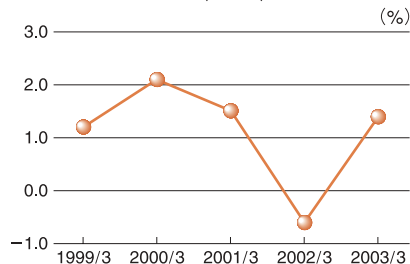

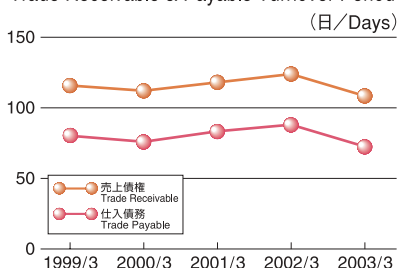

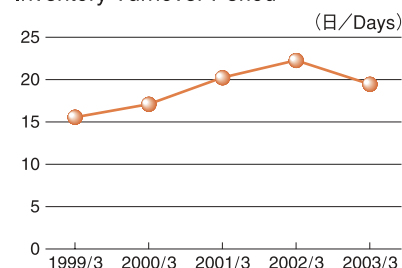

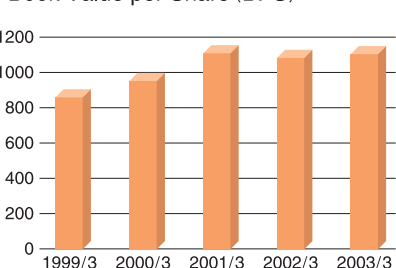

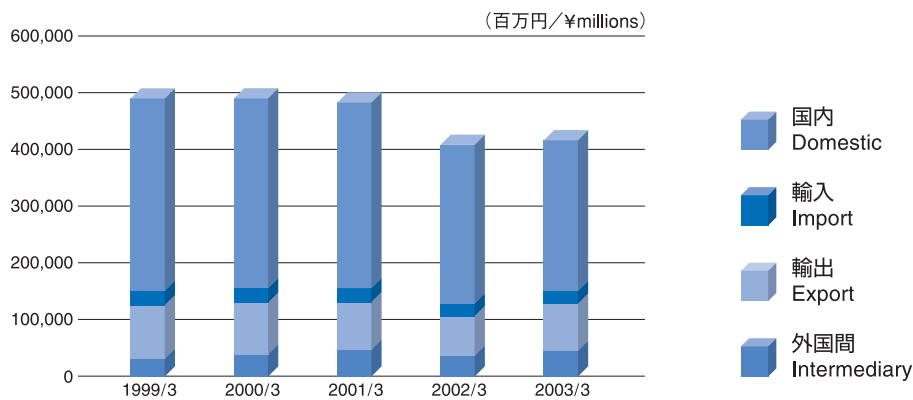

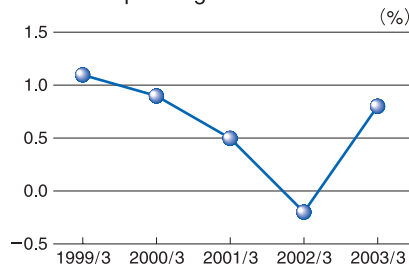

Ratio of Gross Profit to Sales



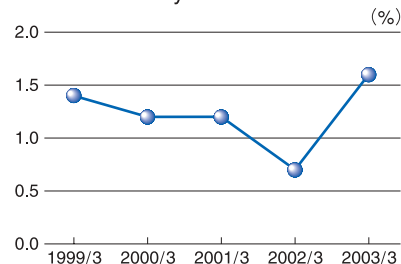

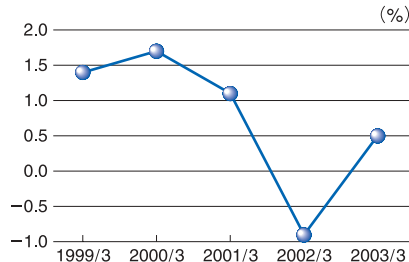

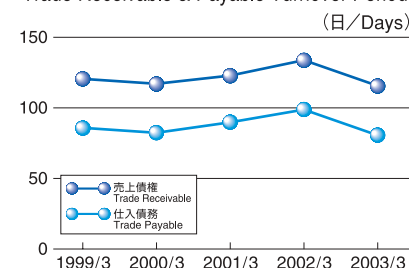

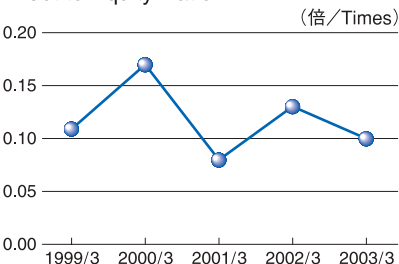

Debt to Total Assets Ratio (%)



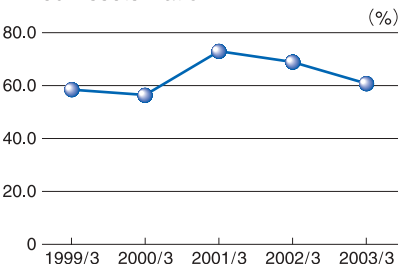

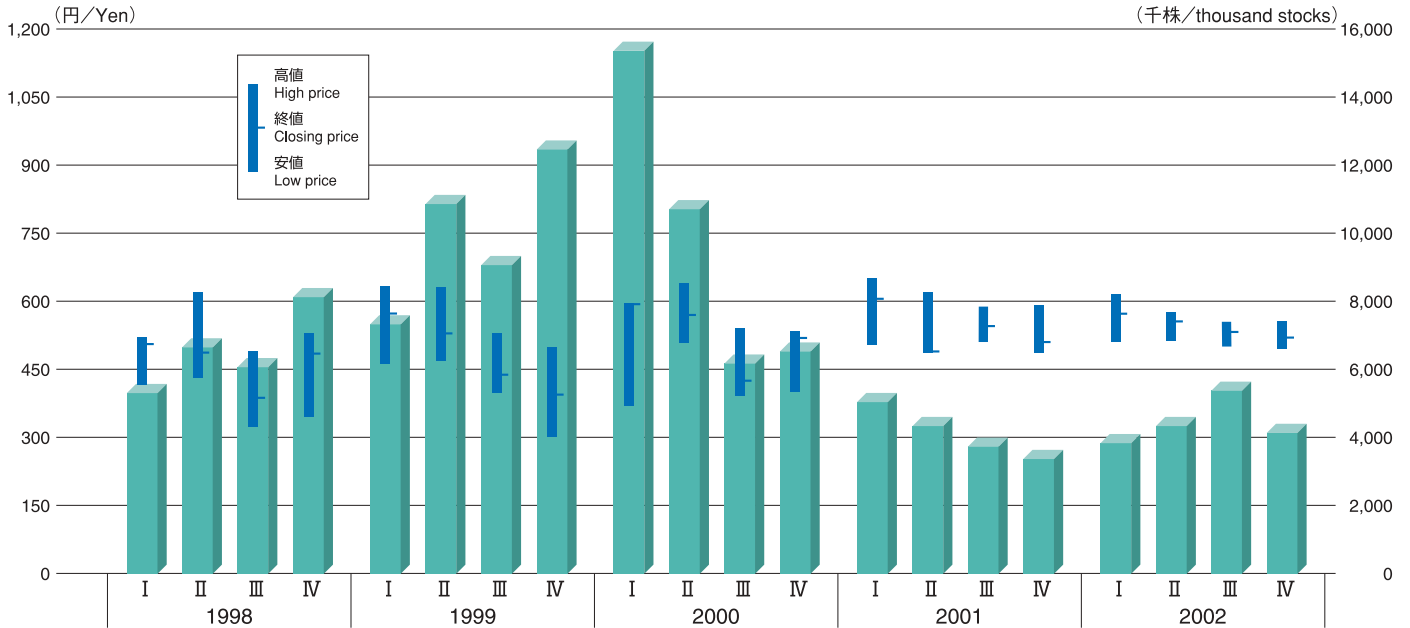

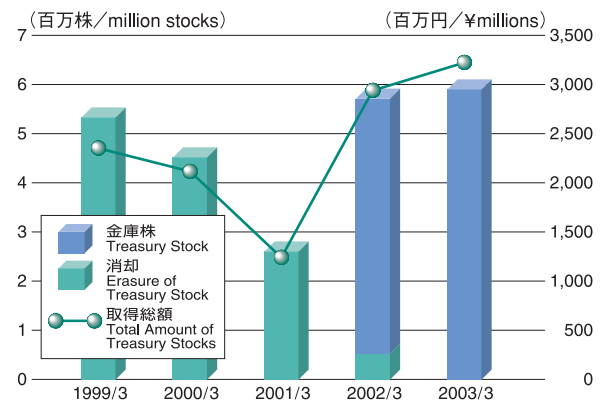
