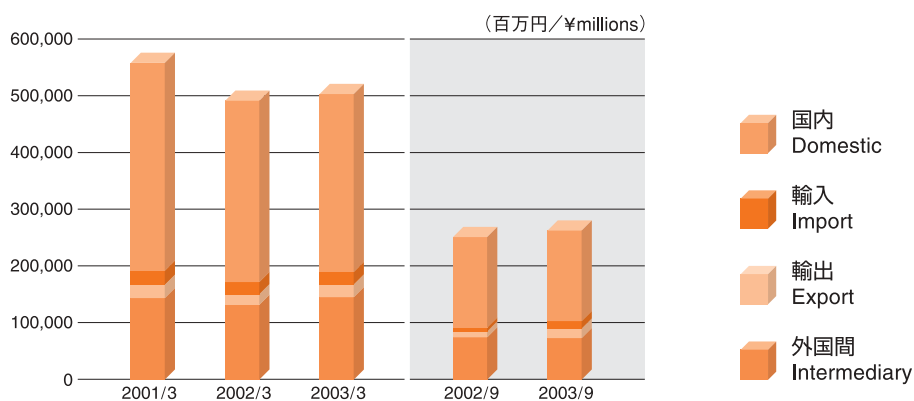

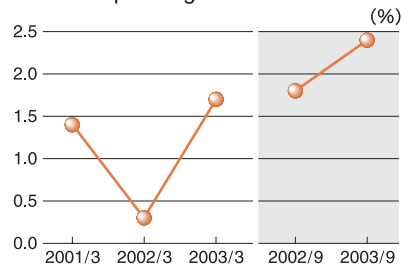

Ratio of Gross Profit to Sales



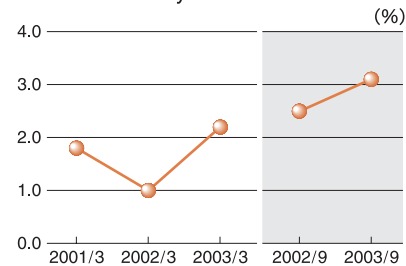

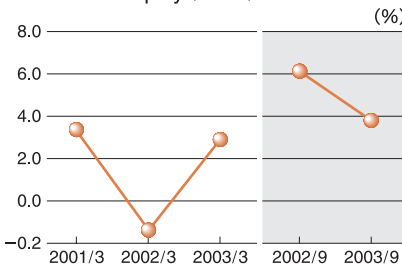

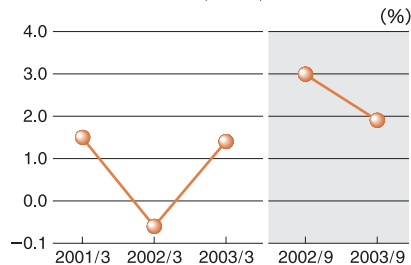

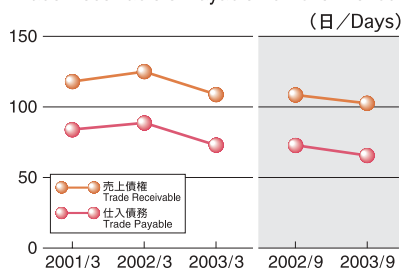

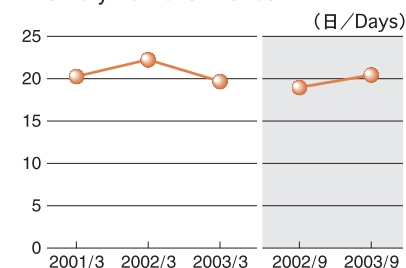

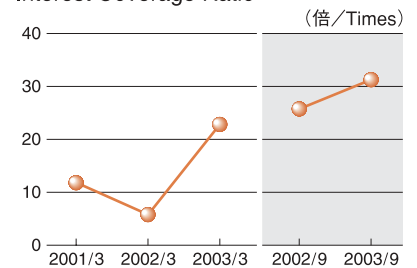

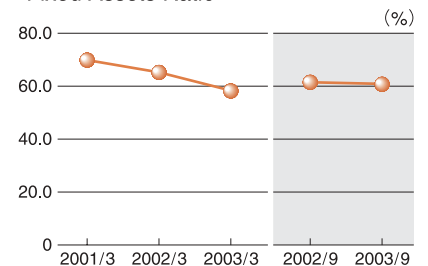

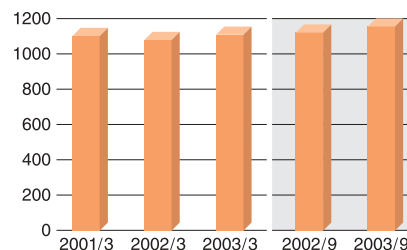

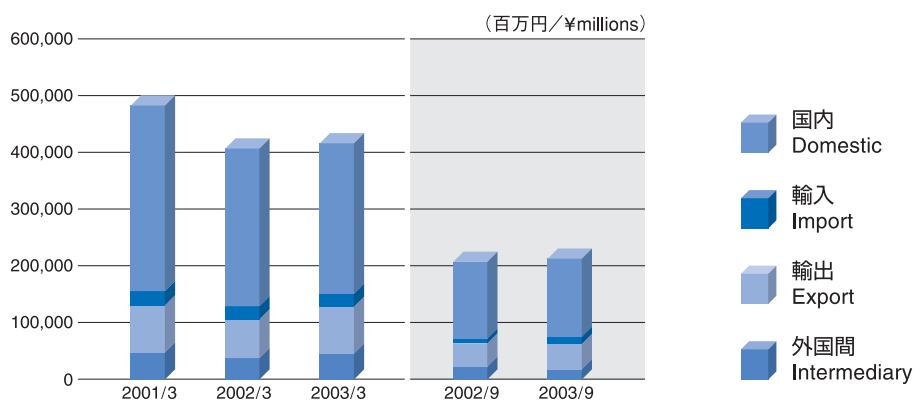

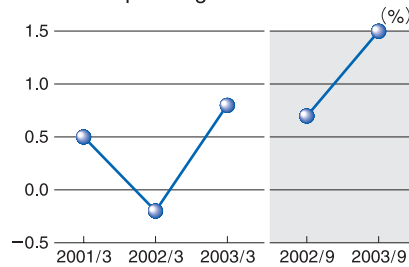

Ratio of Gross Profit to Sales



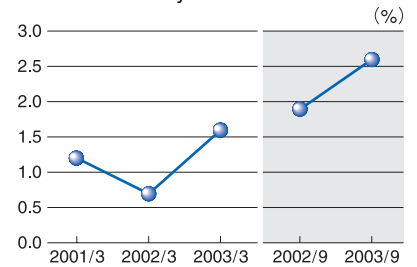

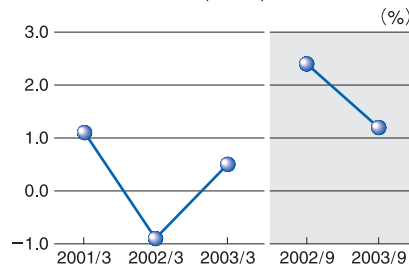

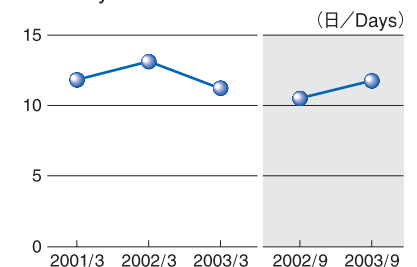

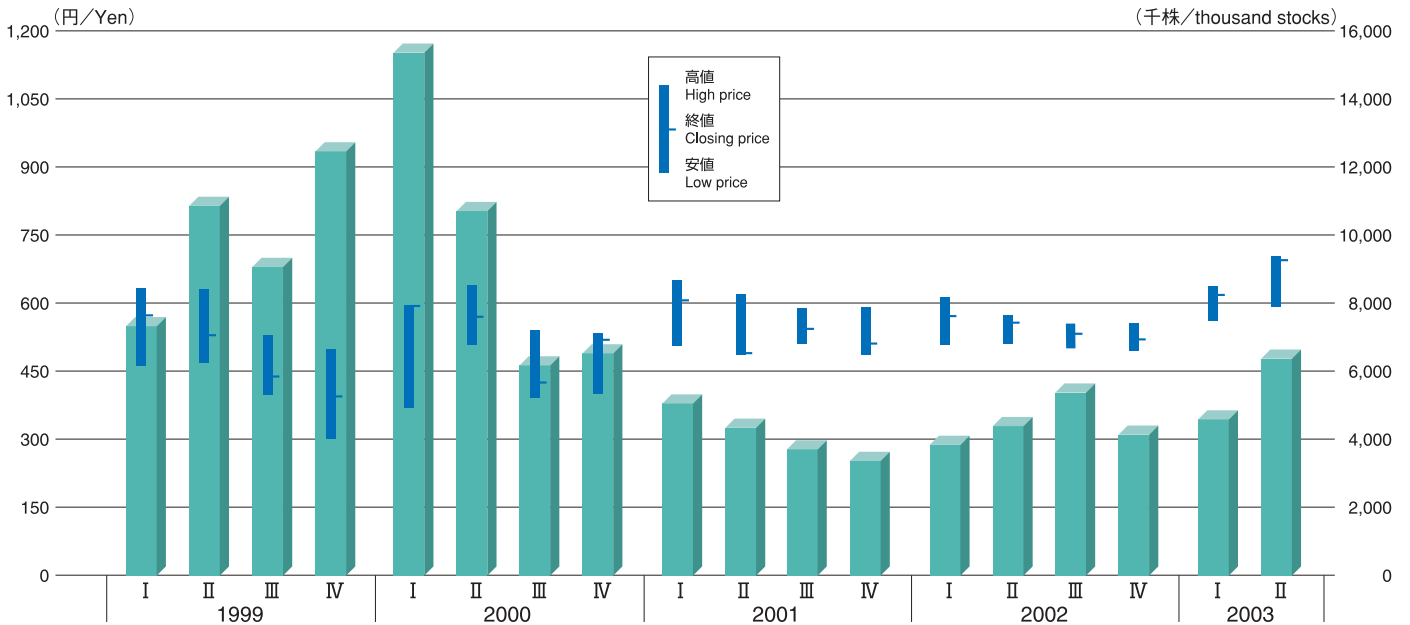

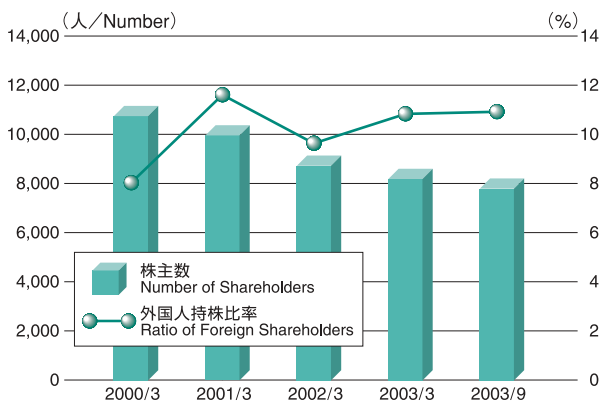

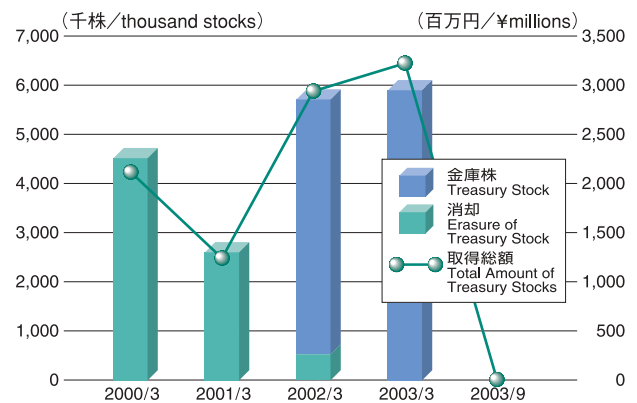
株主の推移

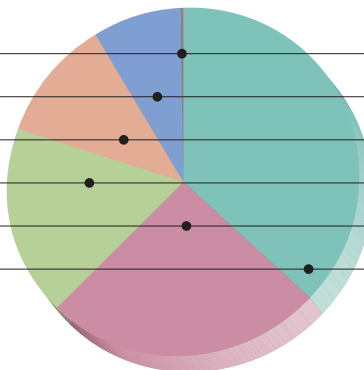
