**Nagase ChemteX Corporation to Consolidate Fukui Yamada Chemical Co., Ltd.  
and Functional Dye Business of Nagase Viita Co., Ltd.**  
—Foundation for Sustainable Expansion and Growth of Chemical Business

Nagase & Co., Ltd. (Head Office: Chiyoda-ku, Tokyo; Representative Director, President and CEO: Hiroyuki Ueshima), as part of the growth strategy in its Medium-Term Management Plan ACE 2.0, has specified the four quadrants of Foundation, Focus, Development, and Improvement, and is carrying out its businesses along the axes of the trading, manufacturing, and R&D functions. With the goal of improving the chemical manufacturing functions related to the quadrants of Foundation, Focus, and Development, as of April 1, 2025, Nagase ChemteX Corporation will gradually consolidate Fukui Yamada Chemical Co., Ltd. and the functional dye business of Nagase Viita Co., Ltd. All three are subsidiaries of Nagase & Co., Ltd.

The goal of this consolidation is to strengthen development and increase production efficiency through fusing technologies, implement business continuity plans as part of a strategy for bases, and increase efficiency of training human resources through greater fluidity of human resources among bases. To that end, the functional dye business of Nagase Viita's Fujita Plant (Fujita, Minami-ku, Okayama) and Fukui Yamada Chemical will be consolidated into Nagase ChemteX.

Since being founded in 1832, the NAGASE Group has expanded its businesses with chemicals as its foundation. Through this consolidation, the Group's chemical technology will be concentrated to sustainably grow NAGASE's chemical businesses. As a company that solves manufacturing issues through materials, the NAGASE Group will contribute to the creation of a sustainable world where people live with peace of mind.
