



Notice of Establishment of Joint Venture Company for Sales of Connectors for Two- and Four-Wheeled Vehicles in India

Nagase & Co., Ltd. (Head Office: Chiyoda-ku, Tokyo; Representative Director, President and CEO: Hiroyuki Ueshima), with the goal of strengthening its foundation in India where future economic growth is expected, has entered into an agreement with Japan Aviation Electronics Industry, Ltd. (Head Office: Shibuya-ku, Tokyo; President: Masayuki Muraki) to establish a joint venture company to expand sales of USB chargers and connectors, due to growing demand for domestic Indian two- and four-wheeled vehicles.





As part of the growth strategy in its Medium-Term Management Plan ACE 2.0, Nagase has specified the four quadrants of Foundation, Focus, Development, and Improvement, and is carrying out its businesses along the axes of the trading, manufacturing, and R&D functions. This establishment of a joint venture company in India is part of the expansion of business in a new area (the Global South), as part of the Development guadrant.

Background and Goal of Joint Venture Company Establishment

India, which has shown impressive economic growth in recent years, is the largest market for two-wheeled vehicles in the world, as well as being the third-largest market and fourth-largest producer* for cars (four-wheeled vehicles). With a national target in place to switch over to electric vehicles, even greater market growth is expected in the future.

The NAGASE Group, with trading, manufacturing, and R&D functions, uses its unique network and technological capabilities to carry out business in 25 countries and regions. The JAE Group operates globally in its three main businesses of connectors, user interface solutions, and aerospace, focusing on technological development and manufacturing to accelerate clients' innovation.

This venture is entering into a partnership between Nagase, which has a history of engaging in a wide variety of businesses in India, and JAE, which provides automotive connectors and harnesses for information and communication systems, safety systems, and EVs to automobile manufacturers and Tier 1 suppliers in Japan, Europe, America, and China.

This joint venture company will sell connectors for two- and four-wheeled vehicles (in-vehicle USBs, etc.), strengthen customer support, build a production system through collaboration with local partners, and strengthen the supply chain in the Indian market, increasing the corporate value of both companies.
