**Transfer of Inkron Oy, Developer and Manufacturer of Functional Materials for
Optical Devices
—Optimal Allocation of Resources for Growth Strategy**

Nagase & Co., Ltd. (Head Office: Chiyoda-ku, Tokyo; Representative Director, President and CEO: Hiroyuki Ueshima), as part of the growth strategy in its Medium-Term Management Plan ACE 2.0, has specified the four quadrants of Foundation, Focus, Development, and Improvement, and is carrying out its businesses along the axes of the trading, manufacturing, and R&D functions.

As part of the optimal allocation of management resources, all shares of optical device functional material developer and manufacturer Inkron Oy (Head Office: Finland), a group company under Nagase ChemteX Corporation (Head Office: Nishi-ku, Osaka; Representative Director, President: Yoshiyuki Morita) which is itself a 100% subsidiary of Nagase & Co., Ltd., will be transferred to Radiant Opto-Electronics Corporation (Head Office: Taiwan), an electronics parts manufacturer in Taiwan, for 1.035 billion yen. The share transfer agreement was concluded on June 25, with the transfer planned to be completed by August 2025.

Reason for Transfer

Inkron Oy was founded in 2013, and has strengths in the development and manufacture of new materials, particularly functional materials for optical devices. Since being purchased in 2017, through research and development in this field the company improved the NAGASE Group's competitiveness, but as part of the revision of business portfolios carried out under the growth strategy in the Medium-Term Management Plan ACE 2.0, a transfer was considered from the perspective of the best owner for Inkron Oy's. Having reached the conclusion that Radiant has ample expertise and experience in this field, and will be able to maximize Inkron Oy's growth,

the decision on the transfer was made.

Impact on Financial Statements

The impact of this transfer on Nagase & Co., Ltd.'s consolidated results will be negligible.
