**Notification of Name Changes to the 3 SACHEM Asia Companies
From April 2026, Nagase Circrea**

Effective April 1, 2026, SACHEM Japan Co., Ltd. (Head Office: Higashiosaka; President and CEO: Satoshi Nakamura), SACHEM (Wuxi) Co., Ltd. (Head Office: Wuxi, China; Chairman: Li Min), and SACHEM KOREA Ltd. (Head Office: Seoul, South Korea; Executive Officer: Satoshi Nakamura), wholly-owned subsidiaries of Nagase & Co., Ltd. (Head Office: Chiyoda-ku, Tokyo; Representative Director, President and CEO: Hiroyuki Ueshima), will change their names to Nagase Circrea Co., Ltd., Nagase Circrea (Wuxi) Co., Ltd., and Nagase Circrea Korea Co., Ltd., respectively. As part of the growth strategy in its Medium-Term Management Plan ACE 2.0, the NAGASE Group has specified the four quadrants of Foundation, Focus, Development, and Improvement, and is carrying out its businesses along the axes of the trading, manufacturing, and R&D functions. This name change is part of an initiative in improving manufacturing capabilities in the semiconductor industry, part of the Focus Quadrant.

In June 2025, Nagase & Co. completed the acquisition of SACHEM Inc.'s high-purity chemicals for semiconductors business in Asia, integrating 5 SACHEM corporations in Japan, China, and South Korea (*1) into the NAGASE Group. On January 1, 2026, the 3 Japanese corporations (SACHEM Japan Holding GK, SACHEM Japan GK, and SN Tech) were merged with SACHEM Japan GK as the surviving company, becoming SACHEM Japan Co., Ltd.

By unifying the company names in Japan, China, and South Korea and aiming to carry out integrated management and improve service under the Nagase Circrea brand, efforts will be made to strengthen the supply chain and increase the value provided globally in the high-purity chemicals for semiconductors business.

By using materials to solve production challenges for customers worldwide, the NAGASE Group will contribute to bringing about a sustainable world where people live with peace of mind.
